### **Submarines Lost/Damaged During the Month of April**

USS S 49 (SS 160) **20 April 1926**. Four men lost.

USS Pickerel (SS-177) **3 April 1943**. All hands lost (74).

USS Gudgeon (SS-211) 18 April 1944. All hands lost (80).

USS Grenadier (SS-210) 22 April 1943. 61 were taken prisoner, 57 survived the war.

USS Snook (SS-279) 8 April 1945. All hands lost (84).

USS THRESHER (SSN 593) 10 Apr 1963. All hands lost (129) including 22 shipyard workers.

USS BONEFISH (SS 582) 24 Apr 1988. Three personnel lost.

## USS S-49 (SS-160) April 20, 1926 – 4 Men Lost



S-48 Class Submarine: Laid down, 22 October 1920, at Lake Torpedo Boat Co., Bridgeport, CT.; Launched, 23 April 1921; Commissioned, USS S-49 (SS-160), 5 June 1922, at Bridgeport, CT.; Decommissioned, 2 August 1927, at Philadelphia Navy Yard, Philadelphia, PA.; Laid up in the Atlantic Reserve Fleet, League Island, PA; Struck from the Naval Register, 31 March 1931; Final Disposition, sold for scrapping, 25 May 1931, to Boston Iron and Metal Co., Baltimore, MD.

Following repairs, S-49 (SS-160) resumed operations off the New England coast; and, during January of 1927, moved south with S-50 (SS-161), for exercises and tests off Key West, the Dry Tortugas, and in Tampa Bay, Florida. On 12 March, S-49 returned to the United States Naval Submarine Base at New London/Groton, Connecticut...whence she completed a run to the Portsmouth Navy Yard at Kittery, Maine; and back to New London/Groton then transited to the Philadelphia Navy Yard at Philadelphia, Pennsylvania, with S-50, for inactivation. Arriving on 31 March, S-49 was decommissioned on 2 August 1927 and berthed with other reserve ships in the Back Channel of the Philadelphia Navy Yard until struck from the Navy List on 21 March 1931 in accordance with the London Treaty. S-49 was sold to the Boston Iron and Metal Company at Baltimore, Maryland, on 25 May 1931. Reduced to a hulk (read "demilitarized") by that company in 1936, but not scrapped, the S-boat was sold to an organization that operated the submarine as an "attraction." The submarine visited many ports in the United States and was "inspected" by interested people who toured through that submersible when she was open to visitors.

During the Second World War, the former S-49 was reacquired by the United States Navy "as equipment" for use in experimental work at the United States Naval Mine Warfare Test Station at Solomons, Maryland...now known as the United States Naval Air Station, Patuxent River Solomons Facility. Shortly after being towed to Solomons from Baltimore (where the Navy had reacquired the submarine), the former S-49 foundered off Point Patience in the Patuxent River on 16 December 1942 and sank in 102 feet of water at: Position: Latitude 38 Degrees 19' 53.2" North Longitude 76 Degrees 29' 17.2" West or, on a bearing of 318.5 Degrees True, distant 525 yards, from the southern tip of Point Patience. The S-boat has remained on the bottom at that position to the present day...and is visited, on occasion, by Navy and recreational divers.

#### Bad Sub Metal Supplier Sentenced to Jail

The Day, New London, Conn, March 05, 2011

The president of a Pennsylvania metal parts broker who supplied improperly treated metal for construction of submarines was sentenced Friday to more than three years in prison. He and his company were ordered to pay \$1.35 million in restitution.

James Bullick, head of Bristol Alloys Inc., admitted in court to supplying a Navy subcontractor with metal that had not been heattreated to meet contractual requirements and was then used in Virginia-class submarines. He was sentenced in U.S. District Court, Eastern District of Pennsylvania.

It could eventually cost the government more than \$30 million to find and replace the metal parts used in the construction of submarines and surface ships over the next five or more years, the Navy's program executive officer for submarines testified at the hearing, according to Assistant U.S. Attorney John J. Pease.

The Navy confirmed Friday that none of the submarine parts at the heart of the criminal fraud case have failed or malfunctioned, and that none of these parts, should they fail, would individually result in a major casualty.

So far, about 10 percent of the inspected parts have been found to be of the wrong material or treatment, and 35 parts have been replaced, or soon will be, on four Virginia-class submarines, according to the Navy. Eight Virginia-class submarines have been inspected.

All other affected submarines and an aircraft carrier have been "cleared," the Navy said. The Navy's investigation also focused on Los Angeles-, Seawolf- and Ohio-class submarines and the aircraft carrier Gerald R. Ford (CVN 78).

Metal from Bristol Alloys was installed in hatches, steering gear, hydraulics, snorkel masts, internal countermeasure launchers and torpedo shipping and handling equipment.

Heat treatment alters the properties of a metal or alloy to make it better suited for a specific application. Bristol Alloys admitted to providing counterfeit certifications that the metal had been treated.

"The government will pursue all available recourses to recoup costs associated with the inspections and rework," the Navy statement said.

The restitution figure was based on the Navy's numbers from last year, when it had spent more than \$1.3 million inspecting ships for the Bristol Alloys metal. Pease said Friday he did not have enough details about the new cost estimates to include them as part of the restitution.

U.S. District Court Judge Mitchell S. Goldberg ordered Bullick to make a monthly payment toward the restitution during his supervised release, an amount initially set at \$200, Pease said.

"Neither one of the defendants has any assets of any significance," he said. "Unfortunately, this is what happens when many fraud cases are concluded."

# US Senator Pryor Introduces Bill to Help Soldiers and Veterans

U.S. Senator Mark Pryor today announced a package of legislation to support members of the military and their communities. These initiatives would provide financial assistance to servicemen and women to rebuild or start up a business, support police or fire departments who must hire a temporary replacement when a member of their department deploys, and provide "veteran" status to certain members of the Guard and Reserves.

First, Pryor introduced the Patriot Express Authorization Act to expedite and prioritize small business loans to members of the military seeking to start, resume or expand a business. It turns a successful Small Business Administration pilot program into a permanent program that provides high-guarantee, express loans to active and non-active military members, veterans, spouses, children and widows or widowers. Members of the military community can use these loans to cover startup or expansion costs, equipment, working capital, inventory or realestate.

Specifically, the legislation increases the maximum loan amount from \$500,000 to \$1 million; provides military members' loans preferential status over other Express loans; reduces fees imposed by the Small Business Administration and processes loans through "express lenders" to reduce wait time to an average of 36 hours.

"Servicemen and women often put their personal lives and careers on hold to serve our country," Pryor said. "We can't ever repay them for their service, but we can provide financial tools so they can jumpstart or expand a business. This is a win-win for our military members and economy."

Second. Prvor introduced the Strengthening Community Safety Act to reimburse police and fire departments as well as ambulance services for extraordinary costs that are incurred when one of their Guard or Reserve members is deployed overseas. The grant program, under the Department of Homeland Security, would reimburse first responder agencies for the salary and equipment of an individual hired to replace an employee or overtime expenses for an employee performing tasks performed by the deployed employee.

"Many communities in Arkansas and across the nation have seen a number of their policemen, firemen, and EMT personnel sent overseas. The additional expense to hire, train and equip a temporary employee poses an economic hardship on these communities," Pryor said. "My legislation provides some assistance and ensures these departments remain well-prepared to respond to emergencies."

Finally, Pryor introduced the Honor America's Guard-Reserve Retirees Act to give Guard and Reserve retirees with 20 years of service the honor of being called a veteran. The current definition of veteran applies only to servicemen and women who served on active duty. While the change in definition does not provide additional financial benefits to a member, the honor enables the qualifying individuals to salute when the Star Spangled Banner is played, march in veterans' parades and be recognized as a veteran by other veterans.

"The sacrifice and service of our Reserve and Guard members should never go unnoticed. This bill is a small step that makes a big difference to all those who served," Pryor said.

#### WWI German U-boat found sunk off Netherlands

A German U-boat of the same era as this one, photographed in 1916, has been found off the coast of the Netherlands.

Dutch researchers found the wreck of a World War I German submarine in 2009 but kept the discovery secret until this week. Radio Netherlands Worldwide reported.

The crew of the research ship HNLMS Snellius hoped they'd found a Dutch submarine that disappeared in 1940, but the vessel turned out to be much older. A brass plate indicated the sub was the German U-106, which sank during World War I, the radio report said.

The announcement of the discovery was delayed while German officials confirmed the sub's identity and sought out relatives of crew members, according to the radio report.

A Dutch navy spokesman told Radio Netherlands the U-boat would not be raised but would be designated a war memorial.
