



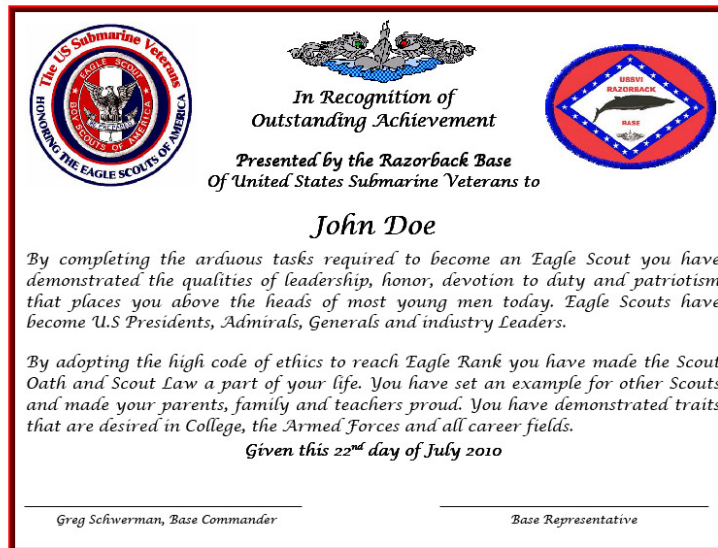
## **USSVI RAZORBACK BASE EAGLE SCOUT RECOGNITION PROGRAM**

We desire to recognize Eagle Scouts throughout the Quapaw Area Council to honor them for this prestigious achievement. We understand an Eagle Scout had many hurdles to overcome. And similar to the way a submariner must overcome hurdles and pass his final review board to qualify to wear the coveted Dolphins; the Eagle must also qualify to wear the Eagle badge as evidenced by completing all the requirements and passing his Eagle Scout board of review.

### **This recognition will consist of the following:**

1. A Certificate as shown below signed by the USSVI Razorback Base Commander and Base Representative for Eagle Scout Recognition:



2. A Patch (shown below) to wear as a sign that the Scout has received this recognition:



3. If possible, the award will be presented to the Scout at his Eagle Court of Honor by a representative of the USSVI Razorback Base.

A Base Representative will respond letting you know whether or not a representative will be attending the Court of Honor so you may include his name on the program. If a representative will not be attending, I will get the items together and ship them to you so you may have someone present them on behalf of the USSVI and the Razorback Base. (We will make every effort to have a representative attend the Court of Honor.)

NOTE: A Razorback Base representative will normally bring these items to the Court of Honor to present to the Scout. All USSVI members are Veterans of the US Navy and were qualified to wear the Dolphins of the US Navy's Submarine Force.
