Submarines Lost/Damaged During the Month of July

USS G 2 (SS 27) **30 Jul 1919**. Three men lost.

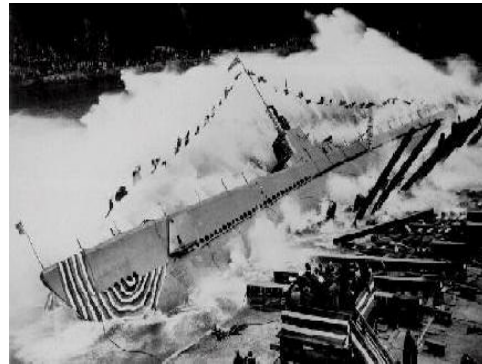
[USS S-28 \(SS-133\) 4-Jul-1944](#). All hands lost (50).

USS ROBALO (SS 273) July 26, 1944 – 81 Hands Lost – 4 Survived

ROBALO under Cmdr. M.M. Kimmel, departed Fremantle on June 22, 1944 to conduct her third war patrol in the South China Sea in the vicinity of the Natuna Islands. After traversing Makassar and Balabac Straits, she was to arrive on station about July 6th and stay there until dark on August 2, 1944.

On July 2nd a contact report stated ROBALO had sighted a Fuso-class battle ship with air cover and two destroyers for escort, just east of Borneo. No other messages were received from ROBALO and when she did not return from patrol, she was reported as presumed lost.



The following information was received via the Philippine guerrillas and an U.S. Navy enlisted man who was a prisoner of war at Puerto Princesa Prison Camp, Palawan, P.I. On August 2, 1944, a note dropped from the window of the prison cell in which survivors from ROBALO were held was picked up by an American soldier in a work detail and given to H.D. Hough, Y2c, USN, another prisoner. On 4 August, Hough contacted Mrs. Trinidad Mendosa, wife of guerrilla leader Dr. Mendosa, who furnished further information on the survivors. From these sources, he put together the following facts.

ROBALO was sunk July 26, 1944, two miles off the western coast of Palawan Island as a result of an explosion of her after battery. Four men swam ashore, an officer and three enlisted men: Samuel L. Tucker, Ens.; Floyd G. Laughlin, QM1c; Wallace K. Martin, SM3c, and Mason C. Poston, EM2c. They made their way through the jungles to a small barrio northwest of the Puerto Princesa camp. They were captured there by Japanese Military Police, and confined in the jail. They were held for guerrilla activities rather than as prisoners of war, it is said. On August 15, 1944, a Japanese destroyer evacuated them, and nothing further is known of their destination or whereabouts. The Japanese may have executed them or the destroyer may have been sunk. At any rate, they were never recovered and their note stated that there were no other survivors.

It is doubted that a battery explosion could be sufficiently violent to cause the sinking of the ship; more likely ROBALO struck an enemy mine.

In her first patrol, in the area west of the Philippines, ROBALO damaged a large enemy freighter. Her second patrol was in the South China Sea near Indo-China where she sank a 7,500-ton tanker.

Military to seek death penalty for USS Cole suspect:

The U.S. military will seek the death penalty against Abd al-Rahim al-Nashiri, making him the first person charged in the United States for the attack on the USS Cole, an Air Force general said Monday.



Seventeen U.S. sailors were killed in the 2000 bombing of the USS Cole in Aden, Yemen.

Al-Nashiri "helped plan and organize and direct the attacks" that killed 17 U.S. sailors while the destroyer was in Yemen in October 2000, Air Force Brig. Gen. Thomas Hartmann said.

The United States accuses al-Nashiri of terrorism, murder, attempted murder and destruction of property, among other charges.

The top lawyer at the Office of Military Commissions Susan Crawford will determine whether the prosecution should go forward and, if so, whether the death penalty should be considered. Yemen has separately charged suspects in the bombing.

Al-Nashiri, a Saudi Arabian national of Yemeni descent, is being held by the U.S. military at Guantanamo Bay. Al-Nashiri says he was tortured into confessing to involvement in the bombing, according to transcripts released by the military. U.S. officials have characterized him as al Qaeda's former operations chief in the Arabian Peninsula.

The CIA has admitted to "waterboarding" **al-Nashiri** at a secret location in 2002; the tapes of the interrogation were destroyed in 2005. The U.S. military's summary of evidence against al-Nashiri said an FBI source identified him as an important person in al Qaeda and "heard" he helped arrange the Cole bombing, according to documents

released by the Pentagon in March 2007. On October 12, 2000, two suicide bombers rammed a garbage barge full of explosives into the USS Cole as the Navy destroyer was refueling in Aden, Yemen. In addition to the 17 killed, 47 sailors were injured, according to the U.S. Defense Department. The blast left a 40-by-40-foot hole in the port side of the Norfolk, Virginia-based guided-missile destroyer, which was carrying a crew of 293.

The Charges

The U.S. military is charging al-Nashiri with:

- conspiracy to violate the law of war
- murder in violation of the law of war
- treachery or perfidy
- terrorism
- destruction of property in violation of the law of war
- intentionally causing serious bodily injury
- providing material support to terrorism
- attempted murder

According to a document released by the government in 2006, al-Nashiri met with Osama bin Laden in Afghanistan in 1998 and received orders to attack an oil tanker off the coast of Yemen. Later the plot changed to target a U.S. military ship, the government alleges. Al-Nashiri also was charged Monday in another plot against a French oil tanker in 2002, the same year he was captured. He was held in secret locations until being transferred to Guantanamo Bay in 2006.

During his Combatant Status Review Tribunal at Guantanamo in March 2007, al-Nashiri acknowledged knowing bin Laden and said he had accepted money from him. But bin Laden gave many people money to help them get married or conduct businesses, al-Nashiri said. Al-Nashiri said he is not a member of al Qaeda, according to the March 2007 documents. He said he knew the perpetrators of the bombing because he had business dealings with them in the fishing industry. Al Nashiri said he "was tortured into confession, and once he made a confession his captors were happy and they stopped questioning him," according to a

statement read during the hearing last year. "Also, the detainee states that he made up stories during the torture in order to get [it] to stop."

Waterboarding involves strapping a person to a surface, covering his or her face with cloth and pouring water on the face to simulate the sensation of drowning. Critics have called it torture. In February, CIA Director Michael Hayden said al-Nashiri was one of three people on whom the CIA had used the harsh interrogation technique. The other two were Khalid Sheik Mohammed, alleged mastermind of the September 11, 2001, attacks, and al Qaeda operative Abu Zubaydah. "We used it against these three high-valued detainees because of the circumstances of the time," Hayden said in February. "Very critical of those circumstances was the belief that additional catastrophic attacks against the homeland were imminent."

Hartmann said Monday the evidence would be examined in court, calling it "the beauty of this system." The judge "will make a final decision as to the validity of any piece of evidence," he said.

Committee votes to protect vet gun ownership

Lists of veterans who have been assigned fiduciaries to handle financial matters on their behalf could not be used to prevent gun ownership under an amendment approved by the Senate Veterans' Affairs Committee on Thursday.

By voice vote, the committee attached to a veterans' health care bill an amendment prohibiting the Department of Veterans Affairs from sharing lists of so-called "incompetent" veterans with the FBI. Only if there has been specific ruling that a veteran poses a risk to himself or others could the VA pass a name on to the FBI for inclusion in records used to make instant background checks before gun purchases, under the amendment to S 2969, the Veterans' Health Care Authorization Act of 2008.

Sen. Richard Burr of North Carolina, ranking Republican on the

veterans' committee and the chief sponsor of the amendment, said the VA makes a determination of incompetence based, primarily, on whether a veteran is capable of handling his own finances. If he cannot, a fiduciary is appointed to handle their benefits.

The VA's sharing of records, done under a memorandum of understanding with the FBI, has resulted in about 116,000 veteran's names being turned over, Burr said. Under current law, veterans have to right to request the removal of their name from the FBI list once it has been turned over, something Burr said presents an unfair burden, especially because other federal agencies, including the Social Security Administration, do not share its records of beneficiaries with fiduciaries with the FBI.

The FBI uses the information in its National Instant Criminal Background Check System. Being listed on that site prevents the purchase of some firearms.

The decision to appoint a fiduciary is an administrative process, decided by a claims adjudicator, who might be an expert in benefits but "are not the ones to be calling the shots on constitutional matters" such as gun ownership, Burr said.

Sen. Daniel Akaka, D-Hawaii, the veterans' committee chairman, tried to discourage Burr, arguing that jurisdiction over the FBI's criminal records system is not a veterans' issue and that more time was needed to study the bill, particularly to get the VA's views.

After Akaka tried but failed to get enough votes to table the amendment, Akaka was among those voting for it. On the voice vote, only Sen. Patty Murray, D-Wash., opposed the amendment.

Murray said she supported "common sense" gun laws but warned that turning over records of incompetent veterans was something that needed careful study. "We want to tread carefully," she said.

VA Plans Two Arkansas Outpatient Clinics

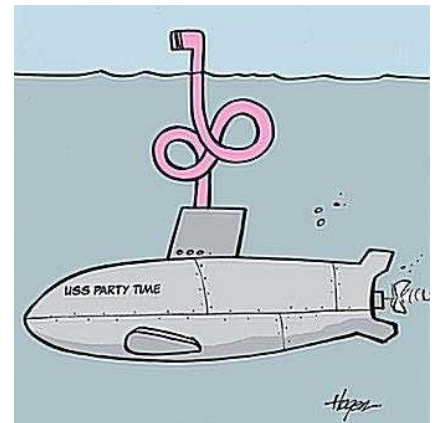
Arkansas veterans of military service won't have to travel to a major city to get routine health care after free-standing outpatient clinics planned by the federal Veterans Affairs Department are opened next year in Searcy and Ozark. Members of the state's congressional delegation announced the plans, saying the two Arkansas clinics would be among 44 new, community-based outpatient clinics planned by the VA in 21 states.

June has been a busy month here at the museum.

First, Riverfest weekend was a HUGE success! We gave tours to nearly 350 people in two days! We sold out of soft drinks and bottled

water, as well as some of the items in our gift shop.

We barely had time to recover from Riverfest when we started our summer hours. For the next few months, we will be open five days a week - Wednesday through Sunday. Wednesday through Saturday, tours will run from 10:00 a.m. to 5:30 p.m. On Sunday, we will be open from 1:00 p.m. to 6:00 p.m.

On June 8th, we loaded the MK 45 ASTOR torpedo into the After Torpedo Room. This torpedo is on loan from the Gyrodyne Historical Foundation. We had originally loaded the torpedo in the forward room, but moved it for historical accuracy. It really helps our visitors get a better feel for how cramped conditions in the ATR were.

We also moved the three MK 14 torpedoes down to the fuel barge, under the canopy. This is a temporary move while we wait for the river level to drop back to normal. These torpedoes are on loan from the US Naval Undersea Museum in Keyport, WA. Two of the torpedoes will be loaded into the Forward Torpedo Room and displayed along with the MK 37 and the third torpedo will join the MK 45 in the ATR.

In the meantime, we have produced a set of five text panels to explain the history, characteristics, and significance of these torpedoes, including their troubled WWII history, to our visitors. The three torpedoes make a great new exhibit and our visitors seem to enjoy learning about them.

A new museum website is in the works and should be up in July. We are also working on sound effects for the tours. We really think they will make the tours "come alive".

We are also making plans for a new temporary exhibit. If you have ideas, you are welcome to submit them to the museum.

Eagle Scout Project at AIMM

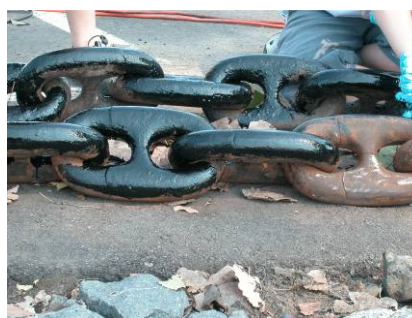
Eagle Scout, John Grove
